Greetings from the B.O.D.

Hello Everyone !

We are sure all of you are welcoming spring. Whatever holiday you are celebrating this spring we hope you enjoy them with family and friends.

The March meeting of the Board was filled with plans for the new fiscal year for the Park. We were pleased to hear that volunteers have stepped forward for the ECC Committee and that the Clubhouse Committee is moving along to plan activities for the Park during the coming season. As you know there are always openings for more volunteers if you are able to donate some time. Pick an activity that you would like to be a part of, we are

sure your help would be welcomed.

There are a few subjects that may have been misinterpreted by some members.

Zoom meetings-We are hopeful that the zoom meetings will be able to continue and improve as we move along. For those who are not aware, during the pandemic no effort was made to have zoom meetings resulting in 18 months of no meetings. Zoom meetings were established by this Board using volunteers and we hope to be able to continue to provide zoom as an option for attending the meetings.

Elections- We have 2 openings occurring this June. As of the March meeting we have received only one resume', which we announced and hope that we will receive more resumes as time moves on and we will announce those as we receive them.

Rules and Regulations- If any member has an issue with the newly published Rules and regulations, please contact the Board through the Website or by mail if you do not use the Internet. Since they were published in February we have not heard one concern from any owner. Our hope is that owners have found them to be fair and not overbearing. Electric Billing- Electric will be billed each quarter. Any owner who has not paid their electric bills for 2 quarters (6 months) will be subject to Electric Shut Off, with a 15 day notice.

Cable Service-This is always an issue and for good reason. There is time between now and when the current contract expires in September 2025. The current Board and the Board that will follow this one will explore options and gather feedback from the owners.

An owner brought up the ADA regulations and how they apply to the Park. We have turned this issue over to the attorney to identify our obligations. We assured the owner that the Board and the Park would honor any obligation we have in this matter. We hope that owners will rely on credible sources for information in regards to issues in the Park. It is important that owners get correct information and not misinformation. There is a fragile balance in the Park after the turmoil resulting from the pandemic. This Board's goal is to bring the Park together for the enjoyment of all owners. We appreciate all the support we receive from members, after all the Board members are also owners and are working for the best interest of the Park.

All homeowners should have received their first quarter statement either by mail or email. Please notify the office if you did not receive one. A new payment schedule was also sent out to all owners. Those who are renting their homes should have received new information and papers that need to be returned to the office. A Worcester County license is also required. Please check your expiration dates. All of this information and more is located on our website www.whpca.org You can download and print any of the forms.

Speaking of forms, please remember that all outdoor changes to your property requires an ECC application. Please also check with Worcester County Permit department to see if a permit is needed. ECC inspections are held once a year in the spring. An inspection list is attached to this newsletter. These are the items that will be checked on your property.

We have 2 openings on the BOD coming up this year. Both are 3 year terms. Please submit your resumes by May 10, 2023. Resumes should include a picture, a brief bio and your goals if you are elected. Ballots will be mailed for you to vote and return. You may also vote before the annual meeting on June 24th. Ballots will be tallied at this meeting. We have one candidate that has submitted a resume. Brian Fenstermacher, our current Treasurer, will be running for a position .

You may receive a 2023 inspection checklist showing the items the ECC noted at your property. There will be a re-inspection 30 days after you receive the notice. If, at that time, the items have not been corrected, the ECC will be at liberty to issue a fine.

Of note, please submit complete ECC applications to the office, please include any sketches, photos, color swatches, and measurements, to the best of your ability so that we may review and approve your application as quickly as possible. As much information you can provide will be greatly appreciated. Reminder, consult the ECC Guidelines for any improvements to your property.

Hello Fellow boaters:

Let me start by saying, the boater family in the park is great. With all the discord and division in the world today, our boaters are kind, understanding and cooperative. I thank each and every one of you for that. It makes my job much easier.

That being said, here is some current information and upcoming events.

*The new Marina Flagpole should be finished being installed by next weekend, April 8th.

*The Marina should be open for slip usage on Saturday April 15, 2023. Any folks having questions (especially new to boating) on how to use a slip or the best techniques of tying off your boat in the slip feel free to contact me.

*I have been in touch with the Coast Guard Auxiliary to come to the Park and do a free safety inspection for our boats to ensure we have all the needed safety equipment.

Upon passing this inspection, they will provide an inspection sticker to apply to your boat that will often prevent any additional inspections or boarding while on the water. I am awaiting a reply from the Auxiliary who have indicated that most likely the inspection will occur on a Saturday in June, probably June 17th or 24th. So, start planning for those dates if you would like to have your vessel inspected. They will also inspect Jet Skis.

*On the day of the Auxiliary Coast Guard inspection, I plan to have our first Hot Dog social, with hot dogs and chips for anyone that wants to attend. It also gives the Coast Guard folks something they can have while out doing the free inspections. Hopefully we can have several Hot Dog socials this summer. ECC CHECKLIST

This ECC checklist is for you. Please check your home for the issues listed below.

Please make sure that **your home and your shed** has house numbers on it. State Law says they must be at least 3 inches tall, a contrasting color of the home, and visible from the roadway. This is important so that they can be seen by Police, Fire and Ambulance.

Thank you for your cooperation.

GROUNDS

Driveway weeds Weeds around skirting Grass overgrown Debris – On property Trees, bushes, etc overgrown – need clearance for mowers Excessive ornamentation – cannot be on the grass (impedes mowers)

<u>HOUSE</u>

House number – at least 3 inches high – visible from street – contrasting color Mold on house Needs painting Roof needs patching, repairing or replacing Trim / Shutters need painting / cleaning Broken windows – deteriorated window treatments Skirting Border around skirting – needed to avoid edger damage

<u>SHED</u>

Mold on shed Needs painting – must match unit color Rotted siding / trim Roof needs patching, repairing or replacing

<u>DECK</u>

Mold on decking and/or railings Warped planks Weeds Railing Missing planks
