Please remember to put your ECC application in the window if you are making improvements and changes to the exterior of your home.

The playground is ready for the children to play. All the play equipment has been power washed and new sand has been added for safety and play.

Lorna Pearre



Served on the WHP Board on two separate occasions. The first time was for 3 years (two years as Secretary and one year as President). I am presently serving the 2nd year of a 2-year term year in the role of Treasurer. I have served on my Church council for a total of 15 years (Council President for 2 years, Vice President for 1 year, Treasurer for 11 years, and Property Chairperson for 14 years). Accomplishments as WHP Treasurer:

- Explained financial reports to owners in a clear and concise fashion.
- Maintained enough cash flow to allow paying the annual insurance premium without paying installment fees. Have also been able to prepay the pool maintenance contract for the past 2 years; resulting in savings this year of over \$2000.
- Established the practice of sending quarterly statement to all owners so that they can keep track of their accounts and rectify any discrepancies in a timely fashion.
- Invested a portion of reserves in high interest CDs. This will produce an additional \$8,000 of interest in the coming year.
- Obtained a business credit card for the office to use for expenses. This will generate 1.5% cash back on purchases. This will replace the use of the debit card that was linked directly to our bank account. Using a credit card is much safer than a debit card, providing protection against fraudulent charges.

Goals if Re-elected:

- Continue to oversee the financials and transparently report them to the owners
- Provide adequate reserves for future repairs and replacements while avoiding special assessments
- Keep WHP well maintained
- Continue to seek ways to save money on expenses and earn money on our reserve investments
